Booking and Payment

- Full payment is required to secure a seat on the bus.
- Payments are accepted through the designated payment methods provided by the Company.
- Booking confirmation will be sent to the Traveler upon receipt of payment.

Cancellation and Refunds

- Cancellations must be made in writing to ahlan@safar.sg.
- Refunds are subject to the following:
 - Cancellations made more than **30 days** before departure: Full refund minus a [\$20.00] cancellation fee.
 - Cancellations made 14-30 days before departure: 50% Refund.
 - Cancellations made less than 14 days before departure: No refund / Only Transferable.

Itinerary Changes

- The Company reserves the right to modify the itinerary due to unforeseen circumstances such as weather conditions, road closures, or other events beyond our control.
- Travelers will be notified of any changes as soon as possible.

Traveler Responsibilities

- Travelers are responsible for arriving at the departure point on time. **The bus will not wait** for latecomers.
- Travelers must comply with local laws and regulations in Singapore at all times.
- Any costs incurred due to a Traveler's failure to comply with the rules and regulations will be the Traveler's responsibility.

Health and Safety

- Travelers should inform the Company of any pre-existing medical conditions or special requirements.
- Travelers must follow safety instructions provided by the Company's representatives and bus staff.
- Travelers are strongly encouraged to purchase your own travel insurance.

Liability

- The Company is not liable for any loss, damage, injury, or expense resulting from factors beyond our control.
- Travelers are advised to obtain travel insurance to cover unforeseen events.

Minimum Participation

• The Company reserves the right to cancel the trip if the minimum number of participants is not met. In such cases, a full refund will be provided.
